Certification and Agreement

The Thomas More College of Liberal Arts, Inc. (TMC) has signed and returned to the Department of Education the Certification and Agreement which assures that TMC has used the funds received under Section 18400(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

Amount received

TMC received \$51,262.00.

Section 18004(a)(1) of the CARES Act

Number of eligible students and amount distributed

All Pell eligible students that attended during the Fall 2020 and Spring 2021 semester received CARES Act monies.

There are 77 students who were eligible to participate in the Federal financial aid programs under Section 484 of the Higher Education Act of 1965, as amended. There were 30 Pell eligible students who received a portion of the grant monies in the amount totaling \$51,262.00.

Calculation

The calculation used to determine how much monies each student received is as follows:
The College calculated the number of students Pell eligible - 30.

Based on the Pell received each students received a percentage of the funds available as follows:

Pell Amount -	\$ 0.00 - \$2,695	received 1.24%

	\$4,196 - \$5,295	received 3.24%
	\$5,296 - \$6,345	received 4.24%
